NOTES FROM NATIONAL

As your National District Council member, I was honored to be the National Rep at the recent Council of Administration meeting in Greensboro. For those of you unable to attend, I would like to share some of the highlights of the points National President Lois Callahan wanted brought to the attention of members.

- National President Lois's Special Project is raising funds to increase the amounts of the Continuing Education Scholarship. Donations may be sent to National headquarters or treasurers may make the donations through MALTA.
- Bonds: the reason the amount of the Bonds being purchased is required to be presented to the Auxiliary and voted on each year, and not just included in the Standing rules is to insure the amount of the bond is the correct amount is purchased to cover the funds of the Auxiliary. In the past, the bond had to be for twice the amount of the current funds. Beginning in July 2026, that amount is reduced to 1.25% of the amount. This was voted on at the 2025 National Convention.
- "Auxiliaries in Action" has been added to the National website to highlight to other Auxiliaries as well as potential new members the various thongs we do everyday for our Veterans, our communities and our organization.
 Be sure to share your pictures. Additionally, the Blogs have been moved behind MALTA.
- There have been some updates to the art contests. One of these is a check-off list for the chairmen to ensure the students are not disqualified at the National level.
- Chain of Command: Please remember to follow the Chain of Command. Try
 to resolve issues at the lowest level possible, starting with your Auxiliary
 President. Followed by your District President (who will notify the
 Department President of any issues of concern) and then to the
 Department President. **DO NOT** contact National directly. They will simply
 refer it back to the Department President. Give her the opportunity to
 resolve the issue.
- Members have asked for the Membership chairman to have member access in MALTA. This is not going to happen. Once solution is to have your Chairman be appointed as your Department Assistant treasurer. The thing to remember about doing this, is that this individual would need to be able to step up and take over as the Department treasurer in the event something were to happen to your treasurer.
- Please report the death of a member as soon as possible Do not wait until
 the end of the year. When trying to achieve 100%, and deaths are not
 reported until the end of the year, it is very difficult to make up these
 numbers. While we should be recruiting all year, we cannot make up
 members in June. Also, check on your Life members. If your
 Auxiliary/Department receives a Lie member payout from National on a

- deceased member, you will be asked to reimburse National for these amounts.
- Any member may attend the National President's Mid-Year and Commander-in Chief's trips. You don't have to be an officer. Check with VTS at National if you would like to book one of these trips.
- National Delegates- Many members often question why they are not a Delegate at the National Convention. Simply registering for Convention, does not make you a Delegate. First you must be elected as one at your Auxiliary meeting. Then, and this is the important part, your Auxiliary Secretary must enter all the Delegates, even of they will not be attending the National Convention in MALTA, by 31 May. This is the ONLY way you can register as a delegate at the National Convention. If your secretary fails to do this or fails to submit the list of delegates to enter to the Department Secretary, not only will you not be a delegate but the Department will lose the votes. (As a side note, for North Carolina at the 2025 National Convention we only had 44 delegate votes, however with the members we had present and registered we should have had over 250 delegate votes had these been entered into MALTA.)
- A new membership application will be rolled out on January 1, 2026. After this date, ONLY the new application can and will be accepted. (The new application will be available on MALTA in late October. Please make sure ALL previous applications are destroyed as to not create any delay in processing of a membership application.)
- There will be a tutorial on Delegates, roll call and credentials. The current plan is to have this ready to roll out by the Sr. Vice Conference

If anyone has any questions regarding any of these points, please reach out to me. As your National Council Member, it is my responsibility to answer any questions you have or take any of your questions or concerns to the National Council.

Many of you have recently been placed in the position of Chaplain. I hope this knowledge will help guide you through your year. You have a very important position, just your presence can make a difference in a life. Always feel free to reach out to me. I am here to listen and pray with and for you. Let me know if there is someone that you would like me to try and reach out to. As a Chaplain in your auxiliary, you have duties that you carry out at each meeting and are often called on to Bless meals. You are most likely the one that sends out cards to those that have had a death or illness. We have others that go beyond this and participate in ceremonies and visit those that are shut in. Some will go to nursing homes and the VA to visit our veterans. As the Chaplain for the Department of North Carolina, I came across this and thought that I would share this with you.

A Chaplain should prioritize compassion, encouragement, and active listening, fostering spiritual and emotional CARE FOR INDIVIDUALS FROM ALL BACKGROUNDS. They provide guidance and support, rather than simply giving advice, while recognizing and respecting the diverse beliefs and needs of those who serve.

Key aspects of a Chaplain:

Ministry of Presence: Being present and available, particularly during times of need, can be more impactful than words. This involves actively listening, showing empathy, and being a supportive presence in various life events

Compassionate Engagement: Chaplains should approach interactions with compassion and understanding, demonstrating care and concern for the well-being of others

Active listening: paying close attention to individuals' concerns, stories and perspectives is crucial for effective Chaplaincy

Spiritual Guidance: Chaplains can provide spiritual guidance, encouragement, and support, helping individuals navigate their journeys and life changes.

Respect and Understanding: A chaplain should be sensitive to diverse cultural, religious, and personal beliefs, avoiding imposing their own beliefs on others.

Ethical Conduct: Chaplains are expected to maintain high ethical standers, including truthfulness, honesty, and integrity in their interactions

Self-Awareness: Chaplains should be mindful of their own biases and limitations, recognizing when they need support or guidance.

REMEMBER: Wisdom, Communication, Humility, Courage, and Patience

Brothers and Sisters,

Welcome to November!

- ➤ I was very happy to see so many of you at the Council of Administration meeting in October. I know there was not a lot of time for treasurer training, because there was a lot of training to get through. I am looking at the possibility of conducting some ZOOM training in the near future. Please be on the lookout for that information.
- The new membership applications are available. I recently emailed them to all of the Auxiliary treasurers and District Presidents, to be shared with all the Auxiliaries. This application is also available on the Department website. Please print these out and have them ready to start using them in December. After 1 January, the new application is THE ONLY application that will be accepted. Any application received on the old forms after 1 January will have to be returned to be completed on the new form. This will cause a delay in the start date for the new member. *Please be sure to destroy all of the old application forms that may be available to your members and in your canteens.* Make sure the Canteen managers only have the new forms. If the video explaining all the changes hasn't been watched, please go into MALTA under Treasurer resources and watch the 18-minute training. It will be very helpful starting in January.
- ➤ While I am mentioning member start dates, an applicant is NOT a member of the Auxiliary until their application has been processed in MALTA and has a membership number. Just because the application has been voted to be accepted by your Auxiliary, that applicant still is not a member until the application is sent in, checked for errors and/or omissions and entered in MALTA. The applicant cannot be elected to hold an office, vote on Auxiliary matters, etc. until they are an official member. They can participate in Auxiliary activities as a volunteer. Never turn down a volunteer ♥ So, please do not hold applications. Send them in as soon as they have been voted on by your Auxiliary.
- ➤ Please remember your 30 September audits are due no later than 30 November. Be sure the audit is presented to the Auxiliary, voted on and accepted before submitting the audit to me. And be sure to include this date on the audit. And it is imperative that the trustees are actually performing the audit and not just signing a form the treasurer completes. This is a violation of the Bylaws and could ultimately cost the trustees should there be a discrepancy in the money of the Auxiliary. Copies of your audit should be given to the Auxiliary secretary as part of the official record, to the Auxiliary President for their records, and of course, keep a copy in your treasurer records.
- And as usual, if you have any questions or need any assistance, please reach out. I am here to help.
